SECTION 7: HANDLING AND STORAGE

7.1 Precautions for safe handling: Avoid dust formation. Avoid high concentrations of dust in air and accumulation of dust on equipment. An airborne dust of this material can create a dust explosion. When handling and processing this material local exhaust ventilation may be required to control dust and reduce exposure to vapors. To prevent dust explosions employ bonding and grounding for operations capable of generating static electricity. Protect all equipment from explosions by following the guidelines in NFPA-68 and NFPA-69. For electrical equipment follow local codes and electrical classification NFPA-70 (the National Electrical Code), class II, division 2, group G. Avoid repeated freeze-thaw cycles; beads may fracture. If frozen, thaw at room temperature.

8.2 Exposure controls
